## **Product Reference/Expiry times**

Customer Services can reference I131 capsules to the day of treatment providing they have received all of the relevant information to do so.

For all other radiopharmaceuticals, we ask you to refer to the attached product availability calendar, this will provide details of activities available, ordering deadlines and reference and expiry information.

It will be the responsibility of the Trust to make decisions regarding delivery days/activities of products required based on this information, Customer Services will not be able to do this for you.

Octreoscan, if ordered on a Friday has an ART of the following Thursday and this is longer than the ART of Octreoscan shipped any other day of the week. It may be more efficient for you to order all Octreoscan to be shipped on a Friday for delivery over the weekend/Monday morning.

We ask, if possible, to keep to your original standing order delivery days during this contingency period to avoid any mistakes being made with deliveries. We would like to keep any impact to a minimum due to the manual process of doing this.
